

**C CPD      Records of the Justices of County of Hull relating      1826**  
**to Non Payment of Rates**

**Historic background:** Amongst the many functions of the Justices of the Peace in a county, was to set the level of the county rate, and this was no different in the County of Hull. As a result, when individuals failed to pay what was required, the Justices could enforce payment.

**Description:** Complaints of William Dickinson (Asst. Overseer for collection of Poor Rates) against individuals for non payment of monies towards relief of the poor

**Extent:** 28 items
