It continues with minutes of annual meetings and special meetings and flags up issues such as ' Conservancy agree to pay one moiety of £1434.4s.3d. as a fair charge on the revenue derived from foreshores'; 'Conservancy to apply to parliament for act to vest in conservancy the foreshores so far as they are vested in Board of Trade'; 'As to payment of two thirds only by conservancy of purchase money - Read's Island'; 'Foreshores Account for 1869 not submittted to Board of Trade'; 'First Authority as to audit of account'. Includes under heading of 'Holderness Embankment & Reclamation Bill' a comparative Admiralty survey of 1684 and 1852.
