Fearnley, General Manager of Sheffield Corporation Tramways acted as an adviser. The committee, looking at co-ordinating transport services across the city, appears to have continued until 1978.

**Historical Background:** With food shortages and rising prices causing significant problems, the newly created Ministry of Food and the Food Controller introduced controls in July 1917 to fix the prices of essential food stuffs. The work of enforcement was devolved to local committees. The Hull Local Food Control Committee was established in August 1917. According to Ministry guidelines, the primary duty of the committee would be to 'safeguard the interests of the consumer'. It should be acquainted with local conditions and have the 'confidence of the public'. It was to carry out the duties of the Ministry of Food, and where appropriate, the Food Controller. It would have no more than 12 members, with at least one woman member and a 'representative of labour'. The City Council opted for 2/3 of the committee to be members of the Corporation with a 1/3 from outside orgainsations. It was finally wound up in June 1920.

From it's establishment in 1905, the council members on the Bureau reported back to the Labour Bureau (Joint) Committee, which was wound up after it's work was completed.
