Historical Background: Originally known as the **Port of Hull Society for the Religious Instruction of Seamen**, the Society was founded in **April 1821**. Its attention was first focused on the spiritual and practical welfare of seamen. They transformed a sailing vessel, 'The Valiant,' into a chapel. Docked in the Humber Dock, the vessel soon became a meeting place for destitute seamen and their families and was often filled to capacity. This floating chapel was only the beginning.

A Sailor's Orphan Institute was established in Waterhouse Lane for clothing and educating the children of deceased seamen and rivermen in 1857. The Society was to move from strength to strength, particularly in the area of welfare and social work. The first orphan home was opened in 1863 in Castle Row. Thanks to a donation by Sir Titus Salt in 1868 a larger home was purchased on Park Street and opened in July 1869. It was at this home that the first children from outside of Hull were admitted. By 1871, out of a total of 148 children, only 70 came from Hull.

A school was established on the Park Street site in 1876. In Jan 1893, anxious to provide a larger, more healthy environment for its children, the Society announced the greatest of all its plans-that of creating a garden village. Eventually 6 acres of land was purchased by the Society on Cottingham Road in 1892 and another 6.5 acres in 1896. The Newland estate took 14 years to complete with the first two houses opening in 1895. Ten houses, a school and a sanatorium were built by 1904. Each house was under the care of a 'House Mother' who looked after 25-30 children of the same sex. It was not until the 1950's that the Society introduced 'mixed' homes where brothers and sisters could live together.

From the 1890's children were selected for entry into the orphanage by way of by-annual elections held on the last Friday of the months of January and July. In the early days no more than two children of the same family were allowed admission to the homes in any one election period and, until 1900, children under 7 years old or over 13 years old were not admitted. In 1900 these rules changed setting the lower age limit to 4 and the upper age limit to 14 for boys and 15 for girls. Subscribers to the Society were given a number of votes depending on the amount that they subscribed. Voting papers were sent to the subscribers at least 14 days prior to the election being held. They included a synopsis of each child's circumstances. Only in very exceptional circumstances were children admitted without having to be the subjects of this election process. The system of elections ceased by the mid-1940's when the Society's Board began to pursue a policy of 'boarding out' children with people who would act as foster parents or else subsidising children to remain in their own homes. The passing of the Children's Act in 1948 also meant that, for the first time, the Home Office became involved in the supervision of voluntary as well as local authority children's homes.

The Society also acted as agents of the Shipwrecked Fishermens' and Mariners' Royal Benevolent Society. Historically this meant that they were responsible for assisting shipwrecked fishermen and mariners landed at or near Hull and Grimsby. The Seafarers' Welfare Officer and the Port Missioner respectively were responsible for discharging the Society's responsibilities which included providing food and shelter, communicating with next of kin and providing clothing, travel and subsistence. They also provided half yearly grants (May and Nov) to those in need of assistance, be they seamen or their widows. In May 1982 they provided grants for 100 individuals.

After 1963 the Society extended its work once more by establishing homes for aged seafarers in Hull, Lowestoft, Fleetwood, South Shields and Grimsby. The Society had noticed that a growing number of seafarers who, because of advancing years, were no longer employable were in need of care and attention. These homes, however, were relatively short-lived because of increased provision for the elderly by local authorities in the late 1970's.

Throughout its history the Society has undergone **several name changes**:

In 1917 the Society changed its name to 'The Port of Hull Society's Sailor's Orphan Homes' due to its increased emphasis on the welfare of children.

In 1950 the Society changed its name to 'The Sailor's Children's Society' in order to avoid using the word 'orphan.'

In **1990** the Society changed its name to **'The Sailor's Families Society.'** A title that reflected their work supporting families throughout the UK and providing residential facilities for elderly seafarers or their widows.

On 1 Dec **2011** the Society reverted back to being known as **'The Sailor's Children's Society'** in order to greater emphasise the fact that they are a children's charity.

In 2003 the last child left Newland and the Society's focus shifted entirely to helping children in their own homes. In 2009 the Newland Site was sold and its new owners converted the houses into student accomodation, although the Society still occupies offices in Francis Reckitt House. They continue to help to support over 420 children from 220 families not only in Hull and the immediate area but also throughout the UK. To qualify for support a member of the family must have served in the Royal or Merchant Navy or the fishing fleets and be in receipt of a means tested benefit. The families are mainly single parent, often as a result of bereavement, or two parent families where one parent is too ill or disabled to work and the other acts as carer. The Society provides monthly grants for essential items, children's clothing grants, help with school trips and offers families the opportunity for a free week's holiday in one of five caravans owned by the Society. The total cost of providing this help is £250,000 per year and the Society relies solely on grants, fund raising, legacies and individual donations.

Custodial history: These records were passed to Hull City Archives in 2005 when the Society began to look for a buyer for their land. In 2009 the Newland Site was sold and its new owners converted the houses into student accomodation, although the Society still occupies offices in Francis Reckitt House. One further accession of admission and leavers registers was made in Sep 2017.

Description: The Records of the Sailors' Children's Society Sailors Orphan Homes (including minutes, annual reports, magazines, admission and leaving registers, applications for entry, case files, correspondence, photographs, Hessle Road Fishermen's Bethel Baptisms, legal and financial records and records relating to the school), the Sailor's Orphan Girls School and Home, Hampstead (Minutes, annual reports, correspondence, admissions, individual files relating to children still at the Hampstead Home at its closure in 1957), the Port of Hull Society's Trustee Company Ltd, Aged Seafarers Ltd, Port of Hull Merchant Navy House Ltd and Childserver's Ltd.

The suggestion was that more attention could be focused on helping aged seamen and their widows and greater preventative work amongst seafaring families could be undertaken. It was felt that this could be achieved by providing short-stay care for children should families benefit from temporary separation for whatever reason. Coincidently, during this time, the Ministry of Health instructed Local Authorities to invoke the aid of Voluntary Organisations in the prevention of the break up of families for the better health of all concerned and for economical reasons. Parents were expected to contribute towards the maintenance of children cared for on a temporary basis and the length of stay varied with each circumstance.

The care of children on a short term basis at Newland began in the middle of 1955. In the 1960's the Society's activities broadened further to include the welfare of aged seamen and their wives and widows, the welfare of able bodied seamen and mission work with elderly ladies, not connected with the sea.

By the early 1980's the The Policy Sub-Committee was more commonly referred to as 'The House Sub-Committee' and the number of children resident at Newland was steadily decreasing with greater emphasis on helping families in their own homes. The Society's main function was still the care of sailors' children but the Social Services Department at that time opposed residential care for children under 11 years old.

Two houses on the Newland estate were used for aged seafarers and there were 3 hostels for teenagers (Trinity House, Titus Salt House and William Richardson House). In 1987, there was also an 'Attendance Centre' set up at Newland for a few hours on a Saturday afternoon to help young offenders (aged 10-17) in conjunction with the Social Services Department and the Home Office.

Other ideas that were considered during the 1980's was a house for mentally handicapped children, a house for physically handicapped children and a single parent and child house. In the late 1980s the The Policy Sub-Committee was more commonly referred to as 'The Homes Utilisation Sub-Committee.'

During this time the adaptation of some of the

houses on the Newland estate to provide nursing home care for aged seafarers was explored as well as the possibility of a Rehabilitation of Juvenile Offenders Hostel. In December 1984 there were 30 children in residential care at Newland, by March 1989 there were only nine children. This led to the diversion of resources away from the Society's main objectives-care of the children of seafarers. Foster care was the preference during these years and there was also a big reduction in shipping and seafaring employment opportunities. During this period a ' Study Group' was set up to ask the question 'How best can the Society Stay in Business?' The study group's aim was to survey the work of the Society and place its proposals and a general summary before the The Policy Sub-Committee. In 1917 the Society changed its name to 'The Port of Hull Society's Sailor's Orphan Homes' due to its increased emphasis on the welfare of children. In 1950 the Society changed its name to 'The Sailor's Children's Society' in order to avoid using the word 'orphan.'

In 1990 the Society changed its name to 'The Sailor's Families Society.' A title that reflected their work supporting families throughout the UK, providing childcare and residential facilities for elderly seafarers or their widows.

In 2011 the Society reverted back to being known as 'The Sailor's Children's Society' in order to greater emphasise the fact that they are a children's charity.

Correspondence relating to post Second World War planning and damage sustained by buildings belonging to the Society during the war.

After the heavy raids sustained by Hull in 1941, a decision was made to evacuate the children even though the homes were in a non-evacuable area. The vacated homes on the Newland estate were taken over for the war effort. William Richardson House was used by the W.V.S. as an office, the Buckston Browne House was a day nursery for babies and small children whose mothers were on war work and the Francis Reckitt House became emergency stores. For several months, the Francis Reckitt House was also used as a hostel for a party of Russian seamen and women who were working on repairing their ship which had been heavily damaged and brought to Hull docks. All the other houses were used as emergency accomodation for people whose homes had been damaged by raids. Stratten Hall was used as an emergency feeding centre. The school was used as storage for emergency supplies, the girl's covered play area was used as a cookhouse. The Hornsea home was also taken over, and used for the duration of the war as military billets for soldiers of all nationalities. The Ministry of Health reimbursed the homes for the use of these buildings but many were unfortunately left in a deplorable condition, not only due to air raid damage but also lack of repair and maintenance to the properties during the war period. A Post-War Planning Committee was established by the Society to oversee any necessary work. (see C DSSF/1/3/9/9 for minutes)

Applications for short stay residential care

The care of children on a short term basis at Newland began in the middle of 1955 when there

was a downward trend in the numbers of orphans of seamen seeking admission into the Homes. It was felt that greater preventative work amongst seafaring families could be undertaken and that this could be achieved by providing short-stay care for children should families benefit from temporary separation for whatever reason. Coincidently, during this time, the Ministry of Health instructed Local Authorities to invoke the aid of Voluntary Organisations in the prevention of the break up of families for the better health of all concerned and for economical reasons. Parents were expected to contribute towards the maintenance of children cared for on a temporary basis and the length of stay varied with each circumstance. These applications relate to children that were in need of short term care. In most cases their fathers were seagoing men and their mothers were having to go away, more often than not, to give birth or have an operation in

The Port of Hull Society's Old Scholars' Association held their inaugural meeting on Sat 20 Jun 1936 in the Stratten Hall on the Newland Estate. This was on the occasion of 'The Grand Re-Union' of scholars. The object of the association was to maintain the traditions of the Homes for the benefit of past, present and future scholars. The desire for an association of this kind had been expressed many times over the years. Eventually the matter was raised by a member of the Board and passed on for consideration by the Welfare Committee whose recommendation that an Association should be established had resulted in the 'Grand Reunion.' It was suggested that the Association's activities would embrace suitable social occasions, sports activities, and general contacts, the underlying principle being the mutual welfare of old and present scholars. The defining of those activities, their scope and action, would be the work of the sectional committees whose formation would be one of the earliest duties of the Executive Committee. It was unanimously decided to adopt the recommendation of the Welfare Committee and proceed with the formation of an Old Scholars' Association. Mr J.H. Ashby was elected Chairman; Mr Sam Walmsley as Hon. Gen. Secretary; Mr E. Watson as Hon. Treasurer, and twelve members were elected to the Executive. The sectional committees created by the Executive Committee were: the social section, the ladies section, the sports section and the benevolent section. During its first year of existence, the Old Scholars' Association attained 216 members.

The Society opened its first school on the floating chapel known as 'The Valiant.' This was a marine school for the purpose of improving the education of sea apprentices. In 1857 the 'Sailors Orphan Institute' was established down Waterhouse Lane for the clothing and education of the children of deceased seamen and rivermen.

Park Street school was opened in July 1873 and, following the move to Newland, land was acquired for the building of a school on the Newland Estate which opened in 1897 and was known as 'Newland Orphan School.' Children attending the school were originally drawn exclusively from what was known as Newland Orphanage.

In 1945 the Board decided that primary school aged children would continue to attend the Homes' School, whilst all the older children would go to LEA Secondary Schools. In September 1951 the school became a Voluntary Aided School. This, in effect, meant that the Hull Education Authority became responsible for the cost of running the school whilst the Society remained responsible for the building itself and the appointment of the teaching staff. The School Managers were composed of four members of the Society's Board together with the Chairman and Vice-Chairman of the Hull Education Committee. Most church schools in the UK existed on the same basis, however this was not a church school. Also, children not resident in the homes were admitted for the first time in 1951 and the name 'St Nicholas' was chosen for the school. This was seen as appropriate because he is regarded as the Patron Saint of children and of Sailors.

In April 1974 the school was taken over by Humberside Education Committee on the same Voluntary Aided basis, reverting back to Hull Education Authority in 1996 with the creation of the unitary authority of Kingston upon Hull. Eventually, by the late 1990's there were no children resident at the homes.

After a period of consultation, in Oct 2006 a 99 year lease was agreed with Kingston upon Hull City Council for the ongoing use of St Nicholas Primary School and Stratten Hall for education purposes.

In 2007 it lost its status as a 'Voluntary Aided' school and was officially named as a 'Community School' to ensure the provision of education for children in the locality. In August 2015 the school took on 'Academy' status as part of the 'ICA Partnership.' The ICA partnership was formed in 2012 and consists of a group of 11 schools, from a range of different contexts, across the City of Hull.

These records mainly comprise of several baptism registers. There is also a bundle of correspondence and a petition against the closure of the Hessle Road Sailor's and Fishermen's Bethel Chapel in 1967 (located at 247 Hessle Road).

One of the baptism registers relates to the Fishermen's Welcome Mission Hall (or Sailor's Welcome), Alexandra Dock. The directors of the Hull and Barnsley Railway and Dock Company granted the Port of Hull Society the site in 1887. It closed in Jul 1913.

The other 6 volumes relate to the Hessle Road Sailor's and Fishermen's Bethel Chapel which opened in 1892. It conducted regular services. There were two services every Sunday and one service every Thursday afternoon solely for the women of Hessle Road. It also served and was used by outside organisations as a centre for the payment of fisherman's wages, compensation and pensions. Countless memorial services also took place there following disasters involving trawlers from the City.

This chapel closed in the late 1960's. The Sailors' Children's Society owned the premises and it was they who decided that the time was appropriate to cease that particular facet of their work. Several reasons were given;

- In the autumn of 1959 the Hull Fishing Vessel Owners Association agreed to relieve the Society of its financial commitment to the Bethel leaving certain duties still to be carried out by the Society in connection with the fishermen's welfare and fishermen's families. The Hull Fishing Vessel Owners Association eventally transferred the Bethel premises back to the Society [1965], and from that date the Hull Fishing Vessel Owners Association began to use the services of the Royal National Mission to Deep Sea Fishermen who had erected a residential hostel for young trainee and visiting fishermen.
- The cost of running the Bethel became considerable and the ability to raise money became more difficult. Mr and Mrs Chappell, the Bethel's Pastor and his wife were nearing retirement and their successors would have to be found and appointed.

 The Society was expanding in other areas of their work, especially with regard to retired fisher-folk, creating a a separate Company called 'Aged Seafarers Homes Ltd.' opening homes in Hull, Grimsby, Lowestoft, Fleetwood, South Shields and Goole to accomodate aged people comfortably in their own rooms for which they paid a modest sum of money thus keeping their individual freedom and identity. The Society's work in Grimsby began in 1842 when the Grimsby Fishermen's Mission was founded. In 1863 there was the first mention of a 'Bethel Chapel' in Grimsby and in 1870 Jesse Mason was appointed as Grimsby's first Port Missioner. The Bethel Mission Church in Tiverton Street, Cleethorpes was erected in 1903 by the Port of Hull Society. Worship there ceased after 27 Mar 1966 and it closed shortly afterwards. The memorial windows and tablets and other treasured memorials were rededicated and re-housed in the Central Hall, Duncombe Street, Grimsby, where a special Chapel for Fishermen was created.

The work of the Society in Grimsby can broadly be divided as follows:

- Practical welfare for the fisherman and his dependants.
- Spiritual welfare at the Fishermen's Bethel, Tiverton Street-later the Fishermen's and Seamen's Memorial Chapel, Duncombe Street, Central Hall, Grimsby.
- Public relations-the collection of monies and encouraging money raising activities for the Society.

Duties were divided between:

- The Port Missioner who dealt with disasters and loss at sea, visited sick fishermen and acted as an honorary agent for the Shipwrecked Mariner's Society. It was part of the job of the Port Missioner to keep records relating to deceased fishermen and access and advise where the most appropriate charitable help could be saught from for their widows or dependents. Port Missioners that served Grimsby include: W.H. Smedley (Port Missioner for 37 years who died in 1935), H. Pickering, A.S. Austin, E.S. Swan (served twice), A Broughton, J.E. Ramsey and I.D.Sankey.
- The Organising Secretary who dealt with collecting subscriptions and donations, organising fund raising events etc.

The spiritual welfare of the fishing community centred around the Fishermen's Bethel Supervision of the work was carried out from the Society's head office in Hull on the Newland Homes Estate. The secretary wrote routine reports and made occasional visits.

Their training included cookery, laundry, and needlework, and at the age of 16 suitable positions were procured for them, and they were given an outfit. Girls who were trained in the Home and placed in service were considered to be under the partial guardianship of the Committee. At some point after 1915 the Sailors' Orphan Girl's School and Home became known as 'The Royal Sailors' Daughters' School and Home' after the Queen paid a visit. It was dissolved in May 1957. On 1 Aug 1957 the Society at Newland took over the affairs of the charity which included transferring some of the remaining orphans into their care in Hull.

C DSSF/4 Aged Seafarers Ltd 1960-1993

After the Second World War, the Society became aware of a new need. There was a growing number of seafarers, who, because of advancing years and infirmity, were no longer employable. An 'ad hoc' committee (later known as the Aged Seafarers' Committee) for Aged Seafarers Accommodation was set up in 1960 to consider a draft scheme for the provision of accommodation for aged seafarers and their widows.

In 1966 the Society decided to form a new company to be known as 'Aged Seafarers Homes Ltd' with the main objective of taking over the management of the Aged seafarers' homes in various ports, especially the fishing ports of Hull, Grimsby, South Shields, Lowestoft and Fleetwood where deprivation seemed most severe.

The reason for the formation of a separate company of this nature was to assist in obtaining grants from Local Authorities.

By Jan 1969 they oversaw the running of 9 homes for aged seafarers but by 1979 only two remained, one at each of the ports of Hull and South Shields. The old sick bay at Newland was converted into aged seafarers accommodation and was officially opened in Nov 1978 by the Society's President, Lord Halifax, as 'Captain Allison House' in honour of an old scholar and Society Board member (in 1979 Captain Allison became Honorary Director and a Vice

President of the Society). Another home was officially opened by Lord Halifax in Jun 1982 at James Reckitt House on the Newland estate but was closed down on 8th Dec 1993. The houses were run on the lines of the Abbeyfield Society which pioneered this special type of service in the 1960's in South East London.

The main principle was to provide accomodation, with a certain amount of care and supervision, for the aged and lonely. The houses were generally quite ordinary; in ordinary streets with accomodation for between 4 and 7 people. The weekly charge covered rent, rates and insurance of an unfurnished room, food, heating, cooking and light, housekeeping items and house laundry, repairs and renewals.

A housekeeper was employed in each establishment and was responsible for providing two main meals each day.

The Port of Hull Merchant Navy House Ltd was incorporated in Aug 1966 as a company limited by guarantee and not having share capital. Their registered office was the Sailors' Children's Society, Cottingham Road, Hull.

The Company's objectives included providing seafarers with residential or non-residential clubs or other centres of recreation, providing financial or other assistance for widows and children or dependants of seafarers and granting pensions to employees and ex-employees or ex-officers of the Association and their widows, children and dependants.

They established a 'Merchant Navy Hotel' on North Street, Goole. The company ceased trading from the 31 Dec 1971. All of its assets were handed to the Sailors' Children's Society as some return for the initial expense that was incurred by that body when Merchant Navy House was set up.

The charity was removed from the Companies Register in 1973 and was eventually removed from the Central Register of Charities in January 1974.

Any profits of the company were to be paid to the Sailors' Children's Society.
