

## **C TCPI    Records of the Hull Corporation Pilots Committee    1885-1891**

**Historical Background:** As a result of having the right to appoint a Commissioner of Pilots, the council decide to establish a Pilots Committee in January 1880. It was to consider and confer on all matters relating to pilotage of the River Humber and report to the council at least once a year on the transactions of the Commissioners. The committee was terminated in November 1899, although the council continued to elect a commissioner until 1907.

**Custodial History:** Records created as part of the work of the Pilot Committee and routinely transferred from the Town Clerks Department

**Description:** Committee records including minutes, correspondence, reports and voting papers

**Extent:** 3 items 6 bundles
