C WF Ferries' Charity for Apprenticing, records 1544-1867

Historical Background: In 1631 Thomas Ferries left property in North Ferriby to the Corporation of Hull, the income from which was to support poor orphans through their apprenticeship. It was consolidated as part of the United Charities of Kingston upon Hull in 1913. From the 1440s until 1835, North Ferriby was part of the administrative county of Hull.

Description: Deeds 1544-1632; will 1630; accounts 1867; receipts and payments 1761-1814; material relating to property at North Ferriby 1630-1818; apprenticeship indentures 1769-1818.

Notes: There are examples of double dating within this collection. Where the date before 1752 is between 1 Jan and 24 Mar, the equivalent modern year is given as well as the old year date e.g. 2 Feb 1566/7. Many of these items were formerly given references in Stanewell's Calendar of the Ancient Deeds, Letters, Miscellaneous Old Documents, &c., in the Archives of the Corporation, 1951. The former reference will be noted on each individual item. The spellings used have also been taken from Stanewell's calendar
