## C WL Lister's Hospital, Hull, records

1614-1869

**Historical Background:** Sir John Lister's Hospital was built in 1642 in South Church Side, Hull. It housed six poor men and six poor women. In 1869 the hospital was moved to Park Street. Lister's Hospital was consolidated as part of the Municipal Hospitals in 1887.

**Description:** Leases and agreements 1614-1832; annual accounts 1867; papers relating to property 1645-1820; plans-1784-1865; correspondence regarding vacancies in the hospital 1868-9; list of residents 1833.
